Executive Summary

As part of a 2006 Cost-Share agreement between the Town of Blacksburg (Town) and the Virginia Department of Historic Resources (DHR), TRC Environmental Inc. (TRC) of Ellicott City, Maryland conducted an architectural survey and survey update of historic resources within the National Register of Historic Places (NRHP)-listed and locally designated Blacksburg Historic Districts (also known as the Town Overlay Zone) in Blacksburg, Virginia. The architectural survey was conducted by TRC between July 2006 and March 2007 within the boundaries of the Town Overlay Zone. The TRC survey included field work and evaluation for NRHP-eligibility of 51 resources currently listed in the Blacksburg NRHP nomination (1991) as "noncontributing," as well as 22 pre-1957 resources located outside of the NRHP district boundaries but within the Town Overlay Zone. Recommendations of the 2006-2007 Blacksburg Historic District Survey include revision of the NRHP Blacksburg Historic District nomination to create a discontiguous historic district, and to extend the Blacksburg Historic District's period of significance beyond the current 1789-1941 period to 1957. No changes are recommended to the boundaries of the Town Overlay Zone.

Project Background and Methodology

Project Background

The downtown commercial and residential areas of Blacksburg, Virginia have been the subject of several survey and historic designation activities. In 1989-1990, this area was surveyed by DHR architectural historian David Edwards as part of an ongoing survey of Blacksburg's historic resources. This survey formed the basis for the preparation of an NRHP nomination for the Blacksburg Historic District, which was listed in the Virginia Historic Landmarks (VHL) Register in 1989 and the NRHP in 1991. In 1996-1997, architect Gibson Worsham, working under contract to the DHR, updated this survey information. The 1996-1997 survey scope included evaluating the contributing or noncontributing status of 1940-1946 resources within the Blacksburg Historic District.

The Town of Blacksburg has designated much of downtown Blacksburg part of a Town Overlay Zone. The boundaries of this historic overlay zone take in additional areas (principally along South Church and South Main Streets and Draper Road) to the west and south of the NRHP boundaries. The boundaries of the NRHP-listed and Town Overlay Zone are shown in Figure 1.

In 2006, the Town of Blacksburg entered into a Cost Share agreement with DHR to conduct an update of the 1996-1997 survey. Through competitive bidding, DHR and the Town retained TRC Environmental Inc. (TRC) of Ellicott City, Maryland to conduct this survey. The purpose of the 2006 Blacksburg Historic District Survey was to evaluate the contributing or noncontributing status of resources dating from between 1946 and 1957 within the NRHP district. An additional task was to survey and evaluate for contributing or noncontributing status all pre-1957 resources located *outside* of the NRHP district boundaries but *within* the Town Overlay Zone. The scope of work for this project also included a report with recommendations on whether the period of significance for the NRHP-listed Blacksburg Historic District should be extended from 1789-1941 to 1957 and whether the boundaries of the NRHP historic district should be revised to make them congruent with the Town Overlay Zone.

Survey Methodology

TRC conducted background research at the DHR Archives in Richmond where the Blacksburg Historic District NRHP nomination was reviewed, along with the DSS forms for previously surveyed, non-contributing resources within the NRHP historic district and Town Overlay Zone boundaries. Additional historic map research was conducted at the Library of Congress in Washington, DC.

A project kick-off meeting was held in Blacksburg on 1 August 2006 among TRC Project Manager Geoffrey Henry, Town Planner Brandol Harvey, and Dr. John Kern and Michael Pulice from the DHR Roanoke Regional Office. Field maps supplied by the Town were reviewed and the boundaries of the Town Overlay Zone were established as the survey project boundaries. TRC conducted fieldwork in the project area between August 1 and August 5, 2006. Updated survey information, including an evaluation of contributing or noncontributing status, was completed on 51 previously surveyed resources. TRC identified 22 pre-1957 resources within the Town Overlay Zone boundaries requiring survey and evaluation. All of the 73 surveyed resources were photographed, mapped, and entered into the DHR Data Sharing System (DSS). The newly surveyed resources were evaluated for their contributing or noncontributing status within a potential expanded Blacksburg NRHP Historic District. The 73 previously surveyed and newly surveyed resources within the project area and the recommendations on their contributing or noncontributing status are listed in the form of an inventory in Table 1.

Survey Findings and Recommendations

Survey Findings

The portion of the locally designated Town Overlay Zone located outside of the NRHP Historic District boundaries contains resources dating from both the pre-1957 and post-1957 periods. Pre-1957 resources are located primarily along Church Street, the east side of South Main Street, and the west side of Draper Road. These areas are separated from each other by concentrations of post-1957 resources located on the east side of Draper Road and the west side of South Main Street.

National Register Bulletin 21 *Defining Boundaries for National Register Properties* (1995, revised 1997) provides guidelines for defining boundaries of historic districts containing discontiguous areas of contributing resources:

"In situations where historically associated resources were geographically separated from each other during the period of significance or are separated by intervening development and are now separated by large areas lacking eligible resources, a discontiguous district may be defined. The boundaries of the discontiguous district define two or more geographically separate areas that include associated eligible resources." (Seifert 1997: 23)

Following consultation with DHR and the Town, TRC developed boundaries for a proposed Blacksburg NRHP Historic District expansion. The boundaries encompass those portions of downtown Blacksburg that retain a significant degree of integrity of historic setting and feeling strengthened by the continuity provided by historic streetscapes. Areas beyond these boundaries generally consist of properties whose character differs from those within the historic district, including the campus of Virginia Polytechnic University (VPI) to the north and west. Properties outside the historic district also include functionally different resources, such as non-historic commercial and governmental properties and large-scale institutional properties. The boundaries of the proposed discontiguous NRHP Blacksburg Historic District are depicted in Figure 2.

Because the newly surveyed and updated resources from the 1946-1957 period continue the development patterns and architectural trends identified as significant in the 1991 Blacksburg Historic District NRHP nomination, TRC recommends that the NRHP Blacksburg Historic District's period of significance be extended to 1957.

Recommendations

Recommendations of the 2006-2007 survey include revision of the NRHP Blacksburg Historic District nomination to create a discontiguous historic district, and to extend the historic district's period of significance from 1789-1941 to 1957. No changes are recommended to the boundaries of the locally designated Town Overlay Zone.
