Hello,

I write to recommend that the U.S. Capitol Commission replace the statue of Robert E. Lee with one of Ona Judge, the woman enslaved by George and Martha Washington who seized her freedom in 1796, and then, eluded the First Family's consistent efforts to recapture her until the end of President Washington's life.

Installing a likeness of Judge alongside that of Washington in the U.S. Capitol would tell a story — the essential story of Virginia: a colony in which representative government first took root was also a place in which enslavement of people of African descent made possible Virginia's wealth and prominence, initially among the colonies and later in the new nation.

Visitors to the Capitol would see Virginia directly confront the tension at the heart of the Commonwealth's history: here, they would see, is the father of the nation, the celebrated general who led the Revolutionary forces in seeking freedom from Great Britain — and here is one of the many people he enslaved, a woman who sought freedom from the man who would bring liberty to white Americans.

Too often, statues flatten history, boiling down complexity into a mass of stone and bronze. Instead, at this juncture, the U.S. Capitol Commission could seek to put Virginia's statues in conversation with one another — and, in turn, encourage all who see them to engage in that same conversation, a conversation Virginians and Americans must have, if we are to own our history and collectively build a better future.

I respectfully submit the following name as suggestion for a historical person to represent Virginia in a new statue for placement in the Capitol.

Elizabeth Van Lew (10/12/1818 - 9/26/1900) Virginia born Elizabeth is deserving of this honor for her inspiring, innovative, and creative thinking. She died relatively unknown. Let her sacrifice to this country be known to all citizens! She had many characteristics that serve today's interests.

During the American Civil War period, Elizabeth cast aside her life many times in support of the Union. She was ostracized where she lived her whole life- Richmond, VA. Elizabeth led a spy network that shortened the War by two years (saving hundreds of thousands of lives), as estimated by Union spymaster George Sharpe.

Elizabeth sent egg baskets to market in Washington, D.C, with notes for General Ulysses S. Grant in some hollowed-out eggs. Boots with hollowed-out heels carried those baskets to market-they held notes as well. Her ciphering system was innovative and quite successful, and she even used disappearing ink! She was known as "Crazy Bet" in adopting an unusual persona for thwarting recognition in accomplishing her goal.

Rescue efforts of Union prisoners of war by Elizabeth prevented dozens being sent to Andersonville, Georgia, known for its almost 30% mortality rate. General Grant paid his respects to her on a side trip after Richmond fell, and gave her a position as Postmistress to Richmond as she was, by war's end, nearly penniless. She made it possible for many freed slaves to purchase property.

Her words: "Slave power crushes freedom of speech and of opinion. Slave power degrades labor. Slave power is arrogant, is jealous and intrusive, is cruel, is despotic, not only over the slaves but over the community, the state."

Let Elizabeth's memory live on in a statue that is the perfect replacement for the one of Robert E.Lee.
