At the end of SHOCKEYSVILLE ROAD Rt 691 you come HOLIDAY ROAD ROUTE 691. Left side 691 the church set on a little rise with cemetery to its east. Behind the church is a cinder block bathroom 8 by 12 built in 1975. TO the east rises SHOCKEY KNOB - named by U.S. geological survey in 1947 elevation 892 feet, first known as THIRD HILL before 1947. Across the road Rt. 691 is located on a hill we have seven shelters, five are Post Build the other two are metal, three have concrete floors. They are shaded by large oak trees, 5 acres of woods behind shelters, A 5 acre open field next to the shelters is fairly level with a walnut grove where POST OFFICE was and now, the SHOCKEY Time Capsule 250 Year Old Shockeys stone is, ITS PEACEFUL,

CHURCH foundation sets on concrete pillars with 3 inch wide 30 feet long runnes outside foundation walls are of slate and cement found on the property. The frame structure made of Lumber cut on Shockey Knob. Walls are wooden side boards covered with white vinyl. East side middle church has a 12 inch block chimney. The front entrance has a 8 foot wide 30 foot long concrete porch sloped on the east end for wheel chairs. Edge of porch has black metal railing. Three door on the front first door is bell tower 30 foot tall with a 1850 Bell under it metal sloped roof. The next two door are 100 year old wooden entrances. Inside of the 30 foot wide 40 foot structure you have 10 stain glass window that are protected by storm windows. 4 window each side and 2 at the 2 stage carpet riser end of building. 4 chadiler lights over head show the crimped metal ceiling. It has 4 electric heater-2 each long side of building. A propane stove setr mid of east wall. This is all covered with a metal Roof installed 2 1/2 years ago. All the shelter are being painted- wooden area, some vinyl gable ends. 3 roof painted-one will be painted concrete floors in two painted. One Roof will be replaced-full part of other shelter roof will receive new metal.

Elizabeth Shockey in 1859 made an agreement Daniel Daile, to take care of his father Samuel Dailey who had consumption T.B. For this she would receive 358 acres of land, Samuel Dailey died 6 months later. The 358 acres became Shockeysville. In 1872 August 17 she donated land for the church, which was built of logs and also used as a school. John Shockey was the first minister. In 1869 John Shockey requested a post office to serve 110 people within 2 miles. The post office was there from 1869-1936. The village had a grist mill, store, blacksmith shop, several houses. Mail was carried on horseback from Whitehall, Va. later by car. John A. Shockey cousin of John Shockey was a minister from Strausburg Va. He came to Shockeysville. First he married John Shockey's daughter Florence who died. He then married Naomi Maggie Shockey her sister. Maggie took care of his children as John was a horseback riding minister 1899-1902 Shockeysville, 1902-1907 Berkeley Springs, 1907-1908 Rawlings, OLD TOWN 1909-1912, Elk Garden 1912-1915, Romney 1915-1917. Riding 20 to 25 miles every Sunday preaching three services. He went into sections that did not have a church and got the communities to build churches. He became known as a church builder in Virginia, West Virginia, and Maryland. He was deaf but could read lips. Working to be could work no more he went home. Maggie Shockey became the leader of Shockeysville church. She got Charles Newkirk to cut timber for the bell tower and bought bell he had bought as scrap. The community men built the tower and installed the 1850 made bell in 1940. They community survived the depression, two world wars - all the time since. Namatta what happened the Luttrells, Masons, Whitacres and other kept coming back to the church. Over 4 generations of Luttrell's have been members of the church. The church has withstood time since 1872 to now.

THE HISTORY OF SHOCKEYSVILLE CHURCH

John Shockey, Son of Lewis Shockey and Susannah Cattlett was born 10 October 1818 in Berkeley County Virginia. On 21 May 1855 he married Elizabeth Davidson in Winchester, Virginia. She was a daughter of Robert and Susan Latem Davidson. The census lists him as a farmer. It is not known if he owned a farm or possibly worked for Daniel Dailey.

In 1859 they made an agreement with Daniel Dailey to care for his father, Samuel Dailey, for as long as he lived. Samuel had consumption and it was difficult to find anyone willing to care for a person who was dying of this contagious disease. John's wife, Elizabeth was actually the one who made the agreement. In return for Daniel's care for as long as he lived, Daniel and Mary Dailey deeded 358 acres to Elizabeth Shockey. In the deed it states that it is for the sole benefit of Elizabeth Shockey, wife of John Shockey, free from the control, debts, contracts and marital rights of her husband, John Shockey or any future husband she may have, that she have sole and exclusive right to do whatever she pleased with the property.

Samuel Dailey lived until September 1859; about six months.

The 358 acres was the beginning of Shockeyville. In 1872 Elizabeth deeded a parcel of land for a Methodist Episcopal Church. The trustees were Henry Luttrell, Jesse Finch, Jesse White John Lamp, Job Clark, George DeHaven, George Nesmith, John Whitacre and John Nesmith. The Church was built of logs donated by John and Elizabeth. At times it was also used for a school.

It is said that John Shockey was the first Minister at Shockeyville. He had a local license. Their children were Edmonia D., Florence Genette, Naomi Maggie, Mary Jane and John Carter.

* - The deed reads as follows:

Original Church Deed Aug. 17, 1872

This indenture made this the 17th day of August in the year of our Lord One thousand Eight hundred and Seventy two between Elizabeth Shockey of the County of Frederic and State of Virginia of the one part, and Henry L. Luttrell, Jesse Finch, Jesse C. White, John W. Lamp, Job D. Clark, George DeHaven, John Whitacre, George Nesmith, and John Nesmith, Trustees, in trust for the use and purpose herein and after mentioned all of the County of Frederick in the State of Virginia of the other part. Witnesseth, that the said Elizabeth Shockey for and in consideration of the sum of One dollar in Specie to her in hand paid at or before the sealing and delivery of these presents, the receipt of which is hereby acknowledged, hath given granted, bargained, sold, released, confirmed and conveyed and by these presents doth give grant bargain sell release and confirm and convey unto them the said Luttrell, Finch, White, Lamp, Clark, DeHaven, Whitacre, Nesmith & Nesmith and their successors all the Estate rights title interest property claim and demand whatsoever either in law or equity which the said Elizabeth Shockey hath in and to a certain lot or piece of land situated lying and being in the county and State aforesaid, bounded & butted as follows, to wit, beginning at a white oak sapling on the south side of the Packhorse Road, thence N 6 degrees W. 11 poles to a gum sapling thence N 67 1/2 degrees E, 13 poles to a maple and chestnut oak sapling thence S. 67 1/2 degrees E. 13 poles to the beginning. Containing 143 poles more or less together with the appurtenances thereto belonging or in any wise pertaining to have and to hold all and singular as above mentioned and described lot or piece of land situated lying and being as aforesaid, all and singular unto them the said Trustees and their Sccessors in office forever in trust and confidence that they shall erect or build or cause to be erected or built thereon a house or place of worship for the use of the members of the "Methodist Episcopal Church" according to the rules and disciplines which may from time to time be agreed upon ad adopted by the minister and preachers of the said Church and in further trust and confidence that they shall at all times forever hereafter permit such ministers and prechers belonging to said church to preach and expound Gods Holy word therein.



And the said Elizabeth Shockey doth by these presents warrant and forever defend all and singular the before mentioned and described property with the appurtenances thereto belonging unto them the said trustees, their successors from the claim or claims of her the said Elizabeth Shockey, her heirs and assigns and from the claims of all others whatsoever.



In testimony whereof the said Elizabeth Shockey has hereunto set her hand and seal the day and year first above written.

Elizabeth Shockey

Shockeysville became a growing community. The road that goes past the church continued on to Winchester, Virginia. There were three dwellings, one grist mill, a blacksmith shop a store a church, a grainery and a few other assorted buildings.

On 10 February 1904 Shockeysville burned to the ground. There is no clear story of how the fire started since everyone was at church. Only the Church was spared.

Rostella B. Shockey Mason was the last child born at Shockeysville. She told of her life in the early 1900's. She told of her daddy, the preacher, of church services, school, the store and Post Office and many other interesting stories. She was treasurer of the church for over 60 years.

When Florence died in 1907, John A. Shockey married Naomi Maggie Shockey and she became a "pillar" of the Church even after John A. passed away. She was known to all the congregation as Aunt Maggie. She was the last one to reside there.

Maggie decided that they needed a church bell. She knew she was getting old and her voice was getting weaker. She loved to sing, but she was afraid that their praises would not be loud enough and that they would lose favor with the Almighty. A friend found a bell for her in a junk yard. It had been the School Bell at Clear Spring, Maryland. Later they tried to buy back the bell but failed. They wanted to return the bell to the new School Building but the bell that once called students to classes now has a higher calling.

The following excerpts are from historical writings of the Baltimore Conference of the Methodist Episcopal Church.

"John A. Shockey, son of Lewis and Mary Catherine Shockey was born near Strasburg, Va. on the 30th of July 1856. He was converted in childhood and united with the Methodist Episcopal Church when he was 13 years of age. He was licensed to preach by the Hedgesville Quarterly Conference in 1893 and after exercising his gifts as a local preacher for several years, gave himself wholly to the work of the ministry. In 1907 he was ordained a local deacon and five years later as a local elder.

Brother Shockey was never admitted to our conference, but served the church as a supply for more than 18 years. His successive appointments were: 1899-1902, Shockeysville Circuit; 1902-1907 Berkeley Springs Circuit; 1907-1908, Rawlings; 1909-1912, Old Town; 1912-1915, Elk Garden and 1915-1917, Romney. As will be seen by this list, his fields of labor were hard, but he devoted himself to the work with affection and zeal. The story of the ministry of Brother Shockey reads like a leaf from the life-history of the early itinerants. He did pioneer work. He rode from 20 to 25 miles and preached three times every Sunday. He entered sections that were unchurched, held revivals and organized societies. He was instrumental in the erection of many churches in the mountain region and these remain as monuments of his zeal for the cause of Christ. His success seems the more remarkable when we consider the fact that he was entirely deaf. He had the ability to read the lips of those who conversed with him and with grace and common-sense, he was able to do far more for the King than many who have the use of all their faculties. He gave glory to God for all that he was permitted to accomplish. He was loved by the people whom he served as a minister of Christ. He was greatly aided in his ministry by the sympathy and support of the wives that God gave him. He was married twice, his wives being sisters. By his first wife, Flora, three children were

born unto him: North Hill, Jenny and Rostella (Aunt Bea). On 14 December 1910 he was united in marriage to Miss Naomi Shockey (Aunt Maggie) , who survives him.

The labors of Brother Shockey on Romney Circuit (his last appointment) were attended by exquisite suffering....pain was often so great that he could not sleep.....he continued to preach as long as it was possible for him to do so. When compelled to retire, he said to his wife: "It is

nearly killing me to leave my work; I can hardly bear it.....so many more people that I want to see converted before I leave. I would like to see the new church at Markwood finished." With heavy hearts, Brother Shockey and Maggie returned to Shockeysville.

In a letter to his District Superintendent, he declared: I am trusting in the Lord at all times. (after a brief summary of his work) he added: "I expect to make my next report in Heaven."....he said to his wife: Tell the people I do not want one bit of credit for what I have done; the Lord has done it all, not I. If I had my life to live over again, I would do much more for him than I have done."

On 17 December 1817 John A. Shockey fell asleep.....He is buried in the cemetery by the Shockeysville Church." (end of Conference excerpts.)

The road that passes by the church is said to be one of the oldest roads in the country called Pack Horse Trail. Settlers moved north west on the trail into West Virginia and westward to Ohio. This helped the small village to prosper. Folks who grew up in the area dreaded traveling that trail through Haunted Hollow north of Shockeysville. The mountain that we see from the church yard and cemetery is called Shockey's Knob. This is not just a local name but is listed with the Department of the Interior, Geographic Names Information System. It is listed as being part in Virginia and part in West Virginia. It is listed as having an elevation of 861 feet.

I have not researched beyond the time when Harry Renner was the minister. The John Shockey that preached from the time the Church was built, was not an ordained Minister so there was no record of him in the conference reports.

The Shockeysville Church was without a regular minister for much of the time between 1968 and the middle 1980s. The faithful tried to hold the congregation together and held services in their homes. In 1985 or 86 the present minister, Rev. Isaac Luttrell came and he has served faithfully to the present time.

ROSENBERGER

John W. Rosenberger, in January 1887, requested that a post office be established in the area of Rosenberger's Mill to serve between 200 to 300 persons in a thickly populated neighborhood. His request was granted five months later, but he never served as postmaster. The post office and store, four miles southwest of Hayfield on the east side of Route 600, was near the entrance to Shawneeland. Mail was supplied two times per week by John Hawkins, contractor for Winchester, Gravel Spring, and Mountain Falls Route Number 11138.

SHOCKEYSVILLE

John Shockey, in 1869, applied for a post office to serve the community of Third Hill. The location of the proposed office was four miles northeast of Collinsville. It would serve a population of 110 within a radius of two miles. An office, named Shockeyville, was established on September 24, 1869, and John Shockey was appointed the first postmaster. Topographical information submitted to the Postal Service in 1898 stated that this office was three and one-fourth miles northwest of Siler, four and one-half miles from Ungers Store and was served by Contract Route No. 14180, Shockeyville to Winchester.

SILER

Application for a post office to be named Crane was made by George W. Whitacre in March 1888. He stated that the office would serve a population of 400. Asked to provide the name of the nearest creek, he wrote "none of any importance." An office was established on May 1, 1888, named Siler. It was located in a log building five and one-half miles north of Gainesboro on Route 600 near its junction with 689. The office later was moved one-half mile east to the junction of Routes 600 and 690 to a site ten rods north of Brush Creek.


STAR TANNERY

Star Tannery post office was established on July 1, 1872. Watson C. Cooper, the first postmaster, stated that there was no village population but the office would serve 500 patrons. Mail was supplied six times per week by the Strasburg to Capon Springs Contract Route No. 4671. The site of the office in 1898, according to the Topographer's office, was three miles northeast of Gravel Spring and one-fourth mile west of Cedar Creek. Request was made by Hesler Himelright, in 1923, to move the office one-fourth mile south and one-eighth mile west of Cedar Creek due to the retirement of the former postmaster. He indicated that 60 patrons resided within a radius of one mile of his office.


